BBG Combo ULD 1700	2 Mbps upto 40 GB, 256 Kbps beyond	4 Mbps upto 100 GB, 256 Kbps beyond
BBG Combo ULD 2150	1 Mbps upto 100 GB, 256 Kbps beyond	4 Mbps upto 175 GB, 256 Kbps beyond
BBG ULD 2150	1 Mbps upto 100 GB, 256 Kbps beyond	4 Mbps upto 175 GB, 256 Kbps beyond
