Subject: Promotion of Broadband service-waiving off the BB Installation charges to Prospective Customers for a period upto 31.07.2010 -reg.

Kind reference is invited to this office circular of even No. dated 27.11.09 (Circular No. 13/09-10) through which the following concession was prescribed to prospective customers for a period of 90 days from 01.12.09 and further extended for a period of 30 days w.e.f. 02.03.10 vide Circular No. 32/09-10 dated 03.03.10.

1. Installation charges for provision of New Broadband connections are waived off irrespective of the Modem having been taken on monthly rental basis from BSNL or purchased by the customer of his/her own.
2. Security Deposit for Broadband (as applicable for the Opted plan) and Modem Security Deposit (in case Modem is taken on hire basis from BSNL) shall be taken in three equal monthly installments starting from the first bill.

Approval of the Competent Authority is hereby conveyed for allowing the above concession as mentioned at Sl. No. 1 above i.e. waiver of BB Installation charges to prospective customers w.e.f. 19.06.2010 to 31.07.2010 for promotion of Broadband Service of BSNL.

All other terms and conditions currently available to New Broadband applicants shall remain the same.
