The Competent authority has decided to introduce the following Promotional **BB Combo Plan with a high speed upto 16 Mbps under both Home and Business category for a period of 90 days. 3. The monthly charges for modems and their sale price will be the same as circulated vide this office letter **No. 64-03/08-Broadband dated 18.02.2010.**
4. All other relevant terms and conditions as per the earlier circulars shall continue to be applicable for this plan also except that, **no volume based discount as circulated vide this office letter No.10-3/Comml./2009-R&C dated 02-04-2009 shall be applicable for the above plan.**


