



Circular R&C-CFA No.28/18-19

Subject: 'Broadband only' plans (without voice facility) 'BBO ULD 490 CS230', 'BBO ULD 590 CS231', 'BBO ULD 890 CS232', 'BBO ULD 990 CS233', 'BBO ULD 1290 CS234' & 'BBO ULD 1590 CS235' and BB plans 'BBG Combo ULD 690 CS236' & 'BBG Combo ULD 1190 CS237' in Punjab Circle-reg.

1. CGMT Punjab Circle may kindly refer to his office proposal vide No. CFA/PB/PM/25/BB/Plan Proposal/36 dated 03-05-2018 seeking approval for Broadband plans in Punjab Telecom circle.

2. The proposal has been examined by the tariff committee and following has been decided by the competent authority:

a) For 'Broadband only' plans (without voice facility) "BBO ULD 490 CS230", "BBO ULD 590 CS231", "BBO ULD 890 CS232", "BBO ULD 990 CS233", "BBO ULD 1290 CS234" and "BBO ULD 1590 CS235" on regular basis in Punjab Telecom Circle only. Details of the plans are as follows:




