CGMT AP Telecom Circle may kindly refer to his office proposal letter No. TA/CS-I/Tariff FTTH/2016-17/6 dated 16-02-2016 seeking approval for waiver of installation charges & security deposit and monthly rental of Rs. 150 for FTTH on landline and broadband (ADSL, VDSL & FTTH) connections for new BB connections under existing BB/FTTH 'BBG Combo ULD 611 CS54', 'BBG Super Speed Combo ULD 995 VDSL CS55' & modified FTTH plan 'Fibro Combo ULD 2795 CS20' available in Hyderabad TD.

The proposal has been examined in this office and the Competent Authority has decided **"to launch the following promotional schemes for a period upto 02-05-2016 in Hyderabad TD only to the new BB customers under BB plans 'BBG Combo ULD 611 CS54', 'BBG Super Speed Combo ULD 995 VDSL CS55' & modified FTTH plan 'Fibro Combo ULD 2795 CS20' who opted 3/6 months payment options and pays the necessary charges in advance:-**
 - (a) To waive off Installation charges for Landline and Broadband.

 - (c) To waive off monthly rental charges of Rs. 150 for FTTH ONT (when taken on rent from BSNL).
