Subject: Re-launch of 'Broadband only' DSL plan (without voice facility) 'BBO ULD 611 CS177' in Hyderabad TD of Telangana Telecom circle only- reg.

1. CGMT, Telangana Circle may kindly refer his office proposal vide letter No. TA/CS-I/Tariff BB/2016-17/43 dated 10-01-2017 seeking approval for re-launch of 'Broadband only' DSL plan (without voice facility) 'BBO ULD 611 CS177' in Hyderabad TD of Telangana Telecom Circle only.
2. The proposal has been examined by tariff committee and the Competent Authority has decided **"to re-launch 'Broadband only' plan 'BBO ULD 611 CS177' [as introduced vide letter No. 1-1/2016-R&C (CFA) [Circular R&C-CFA No. 101/16-17] dated 08-08-2016} on regular basis, only at those places in Hyderabad TD of Telangana (earlier AP) Telecom Circle where BSNL is not able to provide voice facility."**
3. **The circle should ensure that above 'Broadband only' plan is offered at only those places of Hyderabad TD where BSNL is not able to provide voice facility.**
4. All other terms and conditions shall remain same as per earlier circular.
5. The circle shall ensure to comply with all regulatory mechanism and also **update the circle website.**
6. **These instructions shall be effective with immediate effect in Hyderabad TD of Telangana Telecom Circle on regular basis.**
7. This circular is issued based on the approval of Competent Authority in Broadband cell file No. 64-402/2016-17/BB/Tariff. 
