

1. CGM Punjab Telecom Circle may kindly refer to his office proposals vide letter No. CFA/PB/FTTH/01/Proposal/39 dated 16-08-2016, seeking approval of Re-launch of FTTH plans 'Fibro BBG ULD 945 CS30', 'Fibro BBG ULD 1091 CS31', 'Fibro BBG ULD 1441 CS32' & 'Fibro BBG ULD 1891 CS33' in Amritsar, Chandigarh, Ludhiana, Jalandhar, Patiala and Bathinda SSAs.

The proposal has been examined in this office and the Competent Authority has decided **to re-launch FTTH Broadband plans 'Fibro BBG ULD 945 CS30', 'Fibro BBG ULD 1091 CS31', 'Fibro BBG ULD 1441 CS32' & 'Fibro BBG ULD 1891 CS33' plans on regular basis in Bathinda SSA [as introduced vide BSNL CO letter No 1-1/2015-R&C (CFA) (Circular R&C-CFA No. 95/15-16) dated 14-10-2015] and in Amritsar, Chandigarh, Ludhiana, Jalandhar & Patiala SSAs of Punjab Telecom Circle [as introduced vide BSNL CO letter No 1-1/2015-R&C (CFA) (Circular R&C-CFA No. 119/15-16) dated 08-12-2015].**
3. **It should be ensured by the Circle that above plans are offered in only those locations/colonies of the above SSAs where there is a matching competition from private operators.**
4. The Circle shall ensure to comply with all Regulatory Mechanism and **also update the Circle website.**
5. All other relevant terms and conditions, as mentioned in earlier circulars, shall remain unchanged.
6. These instructions shall **be applicable with immediate effect on regular basis in selected SSAs of Punjab Telecom Circle only.**
