



Circular R&C-CFA No. 105/15-16

Subject: Re-launch of BB plans 'BBG Combo ULD 2091', 'BBG Speed Combo ULD 2295' and 'BBG Speed Combo ULD 2841' on regular basis in all the Circles - reg.

1. Kindly refer to the BSNL CO letter No 1-1/2015-R&C (CFA) [Circular R&C-CFA No. 41/15-16] dated 29-06-2015 regarding reformulation of 4 Mbps & 8 Mbps Broadband plans on promotional basis w.e.f. 06-07-2015 in all the Circles.
