Circular R&C-CFA No. 41 /13-14

**Subject: Review of 20% discount scheme to Govt. employees available under DSL and WiMax Broadband services and applicability of the same scheme under FTTH Broadband services – reg.**

Kind reference is invited to Broadband Cell, BSNL C.O. letter no. 1-1/2009-R&C [CFA]64-03/08-Broadband dated 01.12.2008 conveying approval of the competent authority regarding 20 percent discount under DSL Broadband services on rental & usage for the serving and retired Central Government/State Government/ PSU Employees. Kind reference is also invited to T&C-CM, BSNL C.O. letter no. 22-01/2010-T&C-CM dated 29-03-2012 vide which the same discount has been extended under WiMax Broadband services.

2. Now following has been decided by the competent authority:-

- a. To reduce the discount from existing 20% to 10%, for the serving and retired Central Government/State Government/ PSU Employees (existing and new customers) under DSL and WiMax Broadband services.
- b. To extend the 10% discount to the serving and retired Central Government/State Government/ PSU Employees under FTTH Broadband services with the same terms and conditions as applicable under DSL BB services.

3. All other terms & conditions will remain same as per the existing circulars.

4. The above instructions shall be effective w.e.f. 01-10-2013 and the revised discount shall be applicable on the bills issued from 1<sup>st</sup> Nov. 2013 onwards in all the circles/Metro Districts.

5. The circle/ Metro District shall ensure to comply with all regulatory requirements.

6. Impact of the above tariff may be analyzed and feedback may be submitted on monthly basis to T&C-CFA and NWP-BB (CFA) branch of Corporate Office electronically at [tcfa.hq@bsnl.co.in](mailto:tcfa.hq@bsnl.co.in), [tcfa.bsnl@gmail.com](mailto:tcfa.bsnl@gmail.com) and [broadbandbsnlco@gmail.com](mailto:broadbandbsnlco@gmail.com) respectively for further review.
