Subject: Up-gradation of bandwidth in existing Broadband plans 'BBG ULD 545', 'BBG Combo ULD 675' & 'BBG Rural Combo ULD 650' in all the Circles-reg.

1. Kindly refer to Para No. 1(C) of the letter No.1-1/2013-R&C(CFA) [Circular R&C-CFA No. 117/16-17] dated 02-09-2016 vide which Bandwidth of certain existing Broadband plans were revised in all the Circles w.e.f. 01-10-2016.
2. Now, it has been decided by the Competent Authority **to further upgrade the bandwidth of some of the existing Broadband plans for all the existing and new Broadband customers in all the Circles as follows:**

Plan Name	Existing Bandwidth (Download Speed)	Revised Bandwidth (Download Speed)
BBG ULD 545	upto 2 Mbps till 3 GB*, upto 1 Mbps beyond	upto 2 Mbps till 5 GB, upto 1 Mbps beyond
BBG Combo ULD 675	upto 2 Mbps till 3 GB*, upto 1 Mbps beyond	upto 2 Mbps till 5 GB, upto 1 Mbps beyond
BBG Rural Combo ULD 650	upto 2 Mbps till 3 GB*, upto 1 Mbps beyond	upto 2 Mbps till 5 GB, upto 1 Mbps beyond

* w.e.f. 01-10-2016, as per earlier circular no. 117/16-17 dated 02-09-2016.

3. All other terms and conditions shall remain same as per the earlier circulars.
4. The circles shall ensure to comply with all Regulatory Mechanism.
5. These instructions shall **be applicable w.e.f. 01-10-2016 in all the Circles.**
