Subject: Extension of promotional VVoBB tariff in Gujarat circle from 14.01.2012 to 16.02.2012 - reg.

Kind reference is invited to this office letter no. 1-1/2009-R&C [CFA] dated 15.07.2011 (Circular No. 14/11-12) introducing VVoBB tariff plan on promotional basis for 90 days effective from 18.07.2011 in respect of Broadband customers of BSNL in Ahmadabad SSA of Gujarat Telecom circle. The scheme was later launched in all SSAs of Gujarat Telecom circle vide [NWP- BB] branch No.64-44/09-Broadband/SIS dated 25.08.2011. Vide letter no.1-1/2009-R&C [CFA] dated 01.11.2011(circular no.34/11-12), the promotional plan was extended for further period of 90 days in Gujarat circle. Kind reference is also invited to this office letter no. 1-1/2009-R&C [CFA] dated 17.02.2012 (circular No. 58/11-12) conveying approval of the Competent Authority for launching regular VVoBB tariff plan w.e.f. 17.02.2012 in all the circles of North & West zones.

Since there was no approval for VVoBB tariff plan in Gujarat circle from 14.01.2012 to 16.02.2012 i.e the period for which the tariff plan continued after expiry of promotional period, the post-facto approval of competent authority is hereby conveyed **for the extension of promotional VVoBB tariff (issued initially vide circular no. 14/11-12 dated 15.07.2011) from 14.01.2012 to 16.02.2012 in Gujarat circle.**

2. All other relevant terms and conditions as mentioned in above referred circulars shall remain unchanged.
3. This circular is issued based on the approval of Competent Authority in NWP-BB file No. 64-44/09-Broadband/SIS (Pt.6).
