



Circular R&C-CFA No. 08/18-19

Subject: Withdrawal of Broadband plans 'BBG Combo ULD 1000 CS38', 'BBG Combo ULD 1550 CS43' & 'BBG Combo ULD 1845 VDSL CS56' and revision under certain existing Circle specific/PAN India Broadband plans in Odisha Circle-reg.

- CGMT Odisha Circle may kindly refer to his office proposal letter no. CFA-OR/PMSM-004 / 2017-18 / 88 dated 26-02-2018 & email dated 04-04-2018 seeking approval for new Broadband plans, closure of some Circle specific plans and enhancement of Bandwidth in Odisha Circle.
- The proposal has been examined in this office and competent authority has decided **as follows**:
 - To revise existing Circle specific/PAN India DSL/FTTH Broadband plans on regular basis for all the existing as well as new customers in Odisha Circle. Details of the plans are as follows:**


Note: Under above DSL/FTTH Broadband plan, Security deposit for Landline shall be levied as per prevailing instructions.

- b) **Additional facility for Sunday free calling to any network within India shall also be extended as per prevailing instructions.**
- c) **Since all the DSL Broadband plans are available on FTTH with same tariff, above DSL plans shall also be available on FTTH with same tariff.**
- d) **To withdraw existing Circle specific Broadband plans 'BBG Combo ULD 1000 CS38', 'BBG Combo ULD 1550 CS43' & 'BBG Combo ULD 1845 VDSL CS56' for new customers in Odisha Circle.**

Existing customers under above Broadband plans shall continue. However, efforts may be made to migrate these customers to some other DSL/FTTH Broadband plans.

3. The Circle shall ensure to comply with all regulatory mechanism **including online reporting to TRAI and also update the Circle website.**
4. All other relevant terms and conditions, as mentioned in earlier circulars, shall remain unchanged.
5. These instructions shall **be effective with immediate effect on regular basis in Odisha Circle only.**
