Subject: Withdrawal of Circle specific Broadband plans 'BBG ULD 545 CS89' & 'BBG Rural Combo ULD 650 CS90' in Kerala Telecom Circle- reg.

1. CGMT Kerala Circle may kindly refer to his office proposal vide letter No CFA-Mktg./BB Genl Corr/Part-I/2017-18/6 dated 26-07-2017 for seeking approval for withdrawal of Circle specific broadband plans 'BBG ULD 545 CS89' & 'BBG Rural Combo ULD 650 CS90'.
2. The proposal has been examined by the Tariff Committee and following has been decided by the Competent Authority:
 - a) **To withdraw Circle Specific Broadband plans 'BBG ULD 545 CS89' & 'BBG Rural Combo ULD 650 CS90' for new customers in Kerala Circle only.**
 - b) **Existing customers under these plans shall continue. However, efforts may be made to migrate these customers to some other DSL/FTTH Broadband plans.**
3. The Circle shall ensure to comply with all regulatory mechanism **including Online reporting to TRAI and also update the Circle website.**
4. All other relevant terms and conditions shall remain unchanged.
5. These instructions shall **be effective w.e.f. 01-09-2017 in Kerala Circle only.**
