**Subject: Introduction of 'Broadband over WiFi unlimited plans' in Faridabad & Gurgaon SSAs of Haryana Circle and Noida & Ghaziabad SSAs of UP (W) Circle for the Broadband services over WiFi in association with Broadband over WiFi Service Provider (BWSP) - reg.**

1. To offer Broadband and other telecom services on WiFi technology, now, the Competent Authority has decided as follows:

a) To introduce new 'Broadband over WiFi unlimited plans' in association with Broadband over WiFi Service Provider (BWSP) in Noida & Ghaziabad SSAs of UP (West) Telecom Circle [Zone-11] and Faridabad & Gurgaon SSAs of Haryana Telecom Circle [Zone-12] only.

Details of the plans are as follows:

(A) Flat Speed 'Broadband over Wi-Fi unlimited plans' to be provided through BWSP

4. All other terms and conditions shall remain the same.
