Sub: IN Services creation and offline order for migration of existing services - reg.
Ref:- ITPC letter no. ITPC/CDR Project/New features/12 dated 05.09.2013 (enclosed).

At present Commercial & Billing activities for IN Services for Toll Free, UAN, VPN, PRM & UPN in Landline services are being handled manually by respective SSAs through 'Remote Operator Interface' (ROI) terminals. Now, it has been decided by competent authority to migrate/populate existing IN Services/subscriber's database to CDR system for which **validation & testing is already successfully completed**. Televote service is non functional and there is no subscriber for the same as on date, hence no migration is required for the same.

Therefore, it is requested to populate existing IN Subscribers/Services database to CDR system. This population of database in CDR system is being done for the purpose of billing/reconciliation; however the data in SCPs shall continue to be used for the operation of these services.

The procedure to be followed for this migration along with user manual/document and presentation regarding the same, as issued by ITPC circle vide letter under reference, is attached herewith. This job is to be completed as per following schedule:

- Karnataka, Gujrat, Kolkata TD, West Bengal, UP (West), UP (East) & Uttarakhand Circles - **by 31st December, 2013.**
- All other Circles - **From 1st to - 31st January 2014.**
- With effect from **1st January 2014; creation of all new IN subscribers in all the circles** must be done through CDR platform as per the procedure defined by ITPC.

This phase-wise migration has been planned to limit no. of calls to respective ITPC representative for queries from SSAs and for smooth handling of such calls. In case of any problem during migration designated representatives of ITPC may be contacted, whose contact details is given below:
