Subject: Tariff for Cloud Services to be offered from Internet Data Centres set up on revenue share basis with M/s Data Dimension - regarding.

1. BSNL has setup six data centres at Faridabad, Ghaziabad, Ludhiana, Ahmedabad, Jaipur and Mumbai to provide IDC services with M/s Dimension Data as partner (called Data Centre Service Provider, DCSP) on revenue sharing basis.

2. The tariffs for some of the IDC services provided from the above mentioned six data centres in association with M/s Dimension Data were issued vide circular of even No. dated 27.02.2013. Now, it has been decided to launch **Cloud Services** in association with M/s Dimension Data. The tariff for the Cloud Services has been approved by the competent authority and is given below.

3. Cloud Services: BSNL PUBLIC COMPUTE AS A SERVICE (CaaS)

3.3 Bandwidth Charges/Data Transfer Charges

For CaaS, customers access the IDC through Internet using BSNL provided ILL connectivity of the IDC, therefore, in addition to above charges, as mentioned in Para 3.1 & 3.2, BSNL will charge following Data Transfer Charges, which will fully belong to BSNL (i.e not to be shared with the DCSP). Customers have the option to choose one of the Monthly Plans or the Per GB Plan as per their requirement.

4. Other Terms and Conditions:

- (i) All the prices are exclusive of the taxes and duties.
- (ii) The applicable taxes to be paid extra at the time of the billing.
- (iii) Payment Terms – Quarterly in advance, within 30 days of receipt of invoice.
- (iv) Applicable one time charges (if any) are to be paid in advance with the client order form.

- (v) SLA and other terms and conditions will be mutually discussed with the client along with the DCSP and agreed upon.
- (vi) CGMs of the respective circles are authorized to give discounts up to 10% on the price as given in the tariff card to the customers depending on the volume of Business/strategic relationship with the customer. For extending discounts more than 10% in specific cases, CGMs of the respective circles shall refer the cases to corporate office for prior approval.
- (vii) The rates mentioned in the above tariff card (except para 3.3) are for the IDC Cloud Services only and do not include charges for bandwidth requirement of the customers. The rate for the bandwidth portion shall be offered by BSNL and circle shall quote them as per the prevailing practice at that point of time.
- (viii) Before submission of proposal to end customers by BSNL, it shall be ensured that back to back technical proposal is available from M/s Dimension Data for the respective customer.
- (ix) Other commercial conditions and revenue share details etc. will be same as issued by BBNW Circle and IT-CFA.
- (x) Head of Account for IDC services will be same as issued by the CA section.
