Tariff Circular

Subject: Tariff of Managed Network Services (MNS).

BSNL had been providing MNS services in partnership with M/s Trimax IT Infrastructure & Services Limited till 31st Aug 2013, the tariff of which was issued vide No. 112-10/2008-Comml dated 11th Nov 2008, No. 112-10/03-Comml dated 04 Feb 2009 and No. 10-4/EB/2009-R&C dated 3 June 2009. The agreement with M/s Trimax was extended till 31 Aug 2013 after which it was no longer valid and MNS services were not available in BSNL bouquet of services till now.

2. Now, after floating a new EOI, BSNL has signed a new agreement with M/s Trimax to provide MNS services. These new MNS services are not an extension of earlier provided MNS services but new MNS services under new agreement.

3. The MNS services will now be provided under following four flavours:

- (i) MNS service with Router+Modem/Converter+SLA
- (ii) MNS service with Modem/Converter+SLA (without Router)
- (iii) MNS service with Router+SLA (without Modem/Converter)
- (iv) MNS service with SLA only (without Router & Modem/Converter)

Each of these flavours will be available in two SLA types, Gold (99%) & Platinum (99.5%).

4. **Tariff for MNS services:** The competent authority has approved following tariff for MNS services.

5. **SLA Charge:** The above given rates are for Gold SLA (99% SLA) case, i.e. the Gold SLA charge are included in the above given tariff. For providing Platinum SLA (99.5% SLA), 5% extra will be charged on final discounted rates.
6. The above tariff is **exclusive of service tax** and all other levies, which shall be charged extra as applicable from time to time.
7. **Minimum commitment:** The customer has to give a minimum commitment of 24 months initially. In case of pre-surrender or non-payment, BSNL will be free to resort to any action including legal one as deemed fit by them for the recovery of the amount. In this regard, an undertaking may be taken from the customer.
8. **Local lead charges:** The above given tariff is inclusive of local lead charges if these are within local area of telephone system of city/town (virtual node) and can be provide on existing infrastructure.
9. **Expenditure on provision of exclusive OFC (or other) connectivity to the customer for provision of MNS service** shall be governed by the instructions issued vide no. 119-3/2013-BP Ent dated 02 April 2013 and subsequent clarifications.
10. The existing MNS customers will continue in their existing tariff (earlier MNS tariff with discount) till the completion of their agreement/ commitment with BSNL. After completion of their commitment period, the renewal may be done under new MNS service with new tariff.
11. The details and features of the MNS service and terms & conditions of the agreement with the channel partner and revenue sharing etc will be conveyed by the EB-1 cell of this office.
