Subject: Introduction of new FTTH Broadband plans 'Fibro Combo ULD 1099 CS309', 'Fibro Combo ULD 1499 CS310' & 'Fibro Combo ULD 1999 CS311' and withdrawal of Circle specific FTTH Broadband plans 'Fibro Combo ULD 1100 CS71', 'Fibro Combo ULD 1400 CS72', 'Fibro Combo ULD 1699 CS143', 'Fibro Combo ULD 1995 CS62' & 'Fibro Combo ULD 2499 CS144' in Bangalore TD -reg.

1. CGMT Karnataka Circle may kindly refer to his office proposal vide letter No. Mktg-CFA/28-1/LL-BB-FTTH/HPC/Corr/18-19/24 dated 19-06-2018 seeking approval for introduction of new FTTH Broadband plans & withdrawal of existing FTTH Broadband plans in Bangalore TD.
2. The proposal has been examined by the tariff committee and following has been decided by the Competent Authority :


a) *To introduce new Circle Specific FTTH Broadband plans 'Fibro Combo ULD 1099 CS309', 'Fibro Combo ULD 1499 CS310' & 'Fibro Combo ULD 1999 CS311' on promotional basis for a period of 90 days in Bangalore TD. Details of the plans are as follows:*

*Note: (i) Under above Broadband plans, Security deposit for Landline shall be levied as per prevailing instructions.

(ii) The Circle shall ensure that above plans are offered in only those location / colonies of Bangalore TD where there is similar competition from private operator.

- b) **To withdraw existing Circle specific FTTH Broadband plans**
- i. 'Fibro Combo ULD 1100 CS71',
 - ii. 'Fibro Combo ULD 1400 CS72',
 - iii. 'Fibro Combo ULD 1699 CS143',
 - iv. 'Fibro Combo ULD 1995 CS62' &
 - v. 'Fibro Combo ULD 2499 CS144' for new customers in Bangalore TD.
- Existing customers under above FTTH Broadband plans shall continue. However, efforts may be made to migrate these customers to some other DSL/FTTH Broadband plans.
3. The Circle shall ensure to comply with all regulatory mechanism including online reporting to TRAI and also update the Circle website.
 4. The above instructions shall be **effective with immediate effect in Bangalore TD of Karnataka Telecom Circle.**
 5. All other terms and conditions shall remain same as per earlier circulars.
 6. This circular is issued based on the approval of Competent Authority in Broadband Cell File No. 64-461/2018/BB/Tariff. 
