**Circular R&C-CFA No. 31/21-22**

**Subject: Revision of minimum fixed monthly charges (FMC) for opting Static IP (on request) under all the DSL / FTTH / AirFibre / BBoWiFi Broadband plans.**

Kindly refer to the letters No. 1-1/2009-R&C (CFA) [Circular R&C-CFA No. 66/10-11] dated 29-03-2011, 1-1/2009-R&C (CFA) [Circular R&C-CFA No. 25/11-12] dated 25-08-2011 and 1-1/2016-R&C (CFA) [Circular R&C-CFA No. 42/16-17] dated 24-05-2016 regarding Static IP.

2. Now, competent authority has decided as below:

a. **To revise the minimum plan FMC (Fixed Monthly Charges) to opt the static IP (on request) across all the DSL/FTTH/BBoWiFi/AirFibre Broadband plans in all the Telecom circles. Details are as below:**

Broadband Plans with FMC Rs. 2799/- and above	One Free Static IP One additional static IP @ Rs. 1500/- p.a. shall be offered to all the Broadband customers, where one static IP is already available.	Same as Earlier	

**Note: Above charges for static IP shall also be applicable for all the existing as well as new customers of AirFibre / BBoWiFi customers.**

b. **Above charges are non-refundable if customer opts out from eligible Broadband plan FMC (Fixed Monthly Charges) as per above matrix. However, the remaining amount of above charges shall be adjusted against the Static IP charges as per new plan feature only if plan qualifies the eligibility.**

c. **All other terms and condition shall remain same as per earlier circulars issued vide following:**

- Letter No.1-1/2009-R&C (CFA) [Circular R&C-CFA No. 66/10-11] dated 29-03-2011.
- Letter No.1-1/2009-R&C(CFA) [Circular R&C-CFA No. 25/11-12] dated 25-08-2011
- Letter No.1-1/2016-R&C (CFA) [Circular R&C-CFA No. 42/16-17] dated 24-05-2016.

3. Above charges are exclusive of GST.

4. **The circles shall ensure to comply with all regulatory requirements including on line reporting to TRAI and also update the circle website.**

5. The above instructions shall be applicable with immediate effect, **on regular basis in all the circles.**
