Subject: Waival off FTTH ONT rental charges under Broadband plans in Kerala Circle -reg.

1. CGMT Kerala Circle may kindly refer to his office proposal vide letter No. CFA/MKTG/10-35/2017-20/14 dated 07-06-2018 seeking approval for waival of FTTH ONT rental charges for FTTH Broadband connections under annual/higher payment option in Kerala Circle.
2. The proposal has been examined by the tariff committee and the Competent Authority has decided "**to waive of monthly rental charges of Rs. 90/- for FTTH ONT (when ONT is taken on rent from BSNL) only to the existing DSL/FTTH Broadband customers who opted Broadband plan (i.e. Standalone/Broadband only/Combo) with FMC of Rs. 599/- & above under annual/higher payment option in Kerala Circle**".
3. **The Circle shall ensure that the above instruction shall be applicable to non WiFi FTTH ONTs only.**
4. The Circle shall ensure to comply with all regulatory mechanism **including online reporting to TRAI and also update the Circle website.**
5. The above instructions shall be **effective with immediate effect on regular basis in Kerala Circle only.**
6. All other terms and conditions shall remain the same.
7. This circular is issued based on the approval of Competent Authority in Broadband Cell File No. 64-448/2018/BB/Tariff Clarification/correspondence, if any, in respect of above tariff may be sent to Broadband Section, BSNL, Corporate Office, Janpath, New Delhi-110001, T.No.011-23322064 Fax No. 011-23734052.
