**Subject: Withdrawal of PAN India DSL Broadband plan '30GB CUL' and Bharat Fiber Broadband plan '40GB' for new customers in Maharashtra Circle -reg.**

1. CGM Maharashtra may kindly refer to his office proposal vide letter No. CGMT/MH/MKTG & Sales-CFA/SSA Proposals/2017-18/36 dated 22-06-2019 and email dated 22-06-2019 & 17-07-2019, seeking approval for withdrawal of DSL/Bharat Fiber Broadband plans in Maharashtra Telecom Circle.

4. These instructions shall **be effective with immediate effect in Maharashtra Circle.**
5. All other terms and conditions shall remain unchanged.
