Subject: Re-structuring of UITC & FLPP Cards – Regarding

In view of declining sale of Prepaid IN cards due to changed market conditions and to better manage the inventory of variety of Prepaid IN cards effectively and smoothly competent authority has approved re-structuring of UITC & FLPP service as below:

- i. UITC cards may continue to be printed for all denominations viz Rs. 20/50/110/300/550/1100 but **Shelf life** of all such cards shall be **9 months**. (Reduced from present 18 months).
- ii. All the circles shall take PINs of Prepaid IN cards **from Kolkata SCP only**. All other SCPs shall stop creating Prepaid IN PINs **from 15th May, 2013 onwards**.
- iii. No new **FLPP PCO Account** and **FLPP General Account card** is to be created in Kolkata/Ahmedabad SCPs. Even if BSNL field units are having inventory of such account cards, these should not be sold henceforth by BSNL field units. This has been decided because of very little sale of such A/c cards last year.
- iv. **FLPP General Account Card service** is to be closed in due course as the number of total recharge vouchers sold last year was very little. Accordingly no new **recharge voucher** for this service shall be printed. The **existing users may be given suitable notice by field units about closure of this service so that they exhaust their balance before closure of this service**.
- v. In FLPP PCOs validity voucher of Rs 150, FLPP PCO R/C of denomination of Rs. 300, Rs.500, Rs. 1000 and Rs. 3500 will continue whereas FLPP PCO R/C of denomination of Rs. 3000 , Rs.5000 & Rs. 10000 are not to be printed. This shall be effective **from 15th May, 2013**. **Shelf life** of FLPP PCOs validity voucher of Rs 150 & FLPP PCO R/C of denomination of Rs. 300/500/1000/3500 will be **9 months** only.

All circles are requested to take necessary action accordingly in this regard.
