Subject: Regularization of Annual payment option for all existing plans of land line/WLL -Reg.

Kindly refer to this office letter No.3-21/2008-R&C dated 12-11-2008 (Circular No.52), introducing annual payment option facility as a promotional measure for a period of 90 days in all existing plans of Land line /WLL services by levying fixed monthly charges of 10 months against 12 months when payment is made at a time in advance.

This was followed by letter No. 3-17/2008-R&C dated 12-11-2008 (Circular No.53) delegating the powers to CGMs to extend this facility beyond 90 days based on the local market conditions. Thereafter following clarificatory orders were issued in this connection.

3. BSNL CO letter No. 3-21/2008-R&C dated 14-07-2009

2. It has been decided by the Competent Authority to allow the annual payment facility as a regular measure in all existing plans of Land line /WLL service by levying fixed monthly charges of ten (10) months as against twelve (12) months when payment is made at a time in advance.
3. All other relevant terms and conditions shall remain same as contained in existing orders issued in this connection by BSNL Corporate office.
4. These orders shall have immediate effect.
5. This may be brought to the notice of all concerned for taking necessary action.
