Subject: Introduction of charges for change of BB/LL plan, external shifting of landline and Name transfer charges in Tamilnadu Circle-reg.

CGMT Tamilnadu Telecom Circle may kindly refer to his office letter no Mktg/CS-CFA/Tariff-Proposal/09-10/14 dated at Chennai the 20.02.2013 seeking approval for introduction of charges for change of BB/LL plan, external shifting of landline and Name transfer charges.

2) The proposal has been examined in this office and Competent Authority has approved the levy of charges for change of BB/LL plan, external shifting of landline and Name transfer charges in Tamilnadu Circle and other terms and conditions as mentioned below in Tamilnadu Telecom Circle only w.e.f. 01-04-2013.

S.No.	Name of Service	Charges
1	Change of BB Plan	Nil
2	Change of LL PLAN	Nil
3	External shifting of Landline	Rs. 300/- per shift
4	Name Transfer	Rs. 200/- per occasion

3) The above charges shall be applicable in cases where the request of subscriber is complied with within a period of 15 days from the date of receipt of request from the customer. No charges shall be levied in case the activity is not completed within 15 days.

4) CGM of the Circle may exclude certain SSAs, if implementation of these charges is seen to be detrimental to their market share.

5) The Circle should ensure to comply with all regulatory requirements.

6) The impact of this plan may be analysed and report may be submitted immediately after one month of implementation to PDP-CFA branch of corporate office through email to tccfa.bsnl@gmail.com & gmpdpca@bsnl.co.in respectively.
