



**Circular R&C-CFA No. 51/10-11**

**Subject: Revision in ISD tariff of VCC, Land Line/WLL and PCOs –regarding.**

Kind reference is invited to this office circular of even No. dated 07.07.2010 [Circular No. 15/10-11], Circular No. 3-1/2004-R&C (Pt) dated 14.01.09 [Circular No. 67] and Circular No. 3-5/2007-R&C dated 14.01.09 [Circular No. 69] through which the ISD tariff for calls made through 'Universal ITC', BSNL Fixed and WLL phones and Landline/WLL PCOs/VPTs were prescribed.

The Competent Authority has now decided to revise the existing ISD tariff for some countries for (1) Universal ITC/ITC/CALL NOW/GULF CALLNOW/FLPP, (2) BSNL Fixed and WLL phones and (3) Landline/WLL PCOs/VPTs as follows:



2. ISD rates of all other countries will remain as per existing. Charge Band information for new pulses will be issued separately by NWO-CFA cell.
3. The pulses/rates of Land Line and WLL will also be applicable for "BSNL One India"/Other Alternate package and Trunk calls.
4. **The revised tariff will be applicable from 22<sup>nd</sup> January, 2011.**
5. TRAI guidelines regarding increasing any tariff item is to be observed at the time of implementation.
6. This may be brought to the notice of all concerned and necessary steps taken for its proper implementation.


