1. CGMT AP Telecom Circle may kindly refer to his office proposal letter No. TA/Comml-II/19-13/2014-15/86 dated 06-01-2016 seeking approval for waiver of installation charges, Security deposit and monthly ONT rental charges for the FTTH customers who opting 6/12/24 months payment option under FTTH BB plans 'Fibro Combo ULD 645 CS34' & 'Fibro Combo ULD 1045 CS35' in Hyderabad TD of AP Circle.
2. The proposal has been examined in this office and the Competent Authority has decided "**to introduce following promotional schemes for a period of 90 days in Hyderabad TD only to the new BB customers under FTTH plans 'Fibro Combo ULD 645 CS34' and 'Fibro Combo ULD 1045 CS35' who opts annual or higher payment option and pays the necessary charges in advance:-**
 - (a) **To waive off Installation charges for landline and FTTH Broadband.**
 - (b) **To waive off Security Deposit for Landline [For (Local + STD)] and FTTH Broadband plan.**
 - (c) **To waive off monthly rental charges of Rs. 150 for FTTH ONT (when taken on rent from BSNL).**
3. All other terms and conditions shall remain unchanged.
4. **The circles shall ensure to comply with all regulatory requirements.**
5. These instructions shall be effective **w.e.f 23-01-2016 in Hyderabad TD only on promotional basis for 90 days.**
