**Subject: Regularization of BB plans 'BBG ULD 599 CS76', 'BBG Speed ULD 991 CS78' and 'BBG Super Speed ULD 1499 VDSL CS79' in Faridabad SSA of Haryana Telecom Circle only-reg.**

1. CGMT Haryana Telecom Circle may kindly refer to his office proposal vide letter No. Coml/HR/PP-1/LL Tariff Proposal/69 dated 06-06-2016 seeking approval for regularization of BB plans 'BBG ULD 599 CS76', 'BBG Speed ULD 991 CS78' and 'BBG Super Speed ULD 1499 VDSL CS79' in Faridabad SSA of Haryana Telecom Circle only.
2. The proposal has been examined in this office and the Competent Authority has decided "*to re-launch the BB plans 'BBG ULD 599 CS76', 'BBG Speed ULD 991 CS78' and 'BBG Super Speed ULD 1499 VDSL CS79' [introduced vide BSNL CO letter No. 1-1/2015-R&C (CFA) {Circular R&C-CFA No. 88/15-16} dated 01-10-2015] on regular basis in Faridabad SSA of Haryana Telecom Circle*".
3. *Since all the DSL Broadband plans are also available on FTTH with same tariff, the above plans shall also be available on FTTH with same tariff.*
4. *The circle shall ensure that above plans are offered in only those locations/colonies of Faridabad SSA where there is a matching competition from private operators.*
5. The circle shall ensure to comply with all regulatory mechanism ***and also update the circle website.***
6. All other terms and conditions shall remain unchanged.
7. These instructions shall **be effective with immediate effect in Faridabad SSA of Haryana Telecom Circle only on regular basis.**
8. This circular is issued based on the approval of Competent Authority in Broadband Cell File No. 64-133/2014/Tariff/Pt.1.
