**Circular R&C-CFA No. 39/13-14**

**Subject:- Revision of existing ISD tariff of UITC in Paisa/Second & Rs/Minute on the basis of revised ISD tariff of Landline network in Rs/Minute.**

Kind reference is invited to this office letter No. 3-1/2010-R&C (CFA) dated 23.05.2012 & NWO-CFA No. 25-10/2011/NWO-CFA/IN dated 04-06-2012, prescribing tariff in **Paisa / Second for ISD calls** made by using the UITC cards. Reference is also invited to this office letter no 3-1/2010-R&C (CFA) dated 04.07.2013 introducing **MOU based tariff (Rs/Minutes) for NLD/ILD calls** being made by using UITC cards to be created after 15-07-2013 and continuation of Paisa/Second tariff for Cards/e-Pins already generated and circulated either at BSNL/ **BSNL /Distributor or Customer end.**

Keeping in view the change in ILD Carrier Charges, the ISD tariff rate (both for Rs/Minute & Paisa/Second) have been reviewed in this office and approval of Competent Authority is here by conveyed for levy of ISD tariff at revised rates for calls made by using UITC cards to destinations as mentioned in the enclosed **Annexure w.e.f. 01-10-2013**

It is further clarified that TRAI, in its Explanatory Memorandum to Telecom Tariff (Fifty First Amendment) Order 2012 (No. 2 of 2012) dated 20-04-2012, has decided to exclude ILD call rates from the purview of tariff protection envisaged vide 43<sup>rd</sup> amendment. As such any upward or downward revision in ILD tariff shall be applicable to all subscribers uniformly irrespective of the date on which the subscriber was enrolled into a tariff plan.
