**Circular R&C-CFA No. 51/16-17**

**Subject: Tariff for pre-paid Landline services on PAN India basis.**

1. The Competent Authority on recommendation of Tariff Committee – CFA has approved following tariff plan for prepaid landline services. The detail is as follows:-

Pre-paid Landline Tariff Plan		
S. No.	Particular	
1	<b>Registration Charges</b>	Rs.500/- (Only in case of waiting list)
2	<b>Installation Charges:-</b>	Rs.600/- both for Rural & Urban
3	<b>Instrument charges</b>	Rs.600/- for CLIP instrument
3	<b>Security Deposit</b>	No security Deposit
4	<b>Subscription Voucher</b>	Subscription voucher of Rs.550/- for validity of 90 days only and Rs.50/- talk value. For continuity of service, the customer is required to charge the prepaid connection with subscription voucher of Rs.550/- before expiry of the validity period of 90 days.
5	<b>Talk value vouchers</b>	Rs.50/- : talk value Rs.40/- only. No validity period. Rs.100/- talk value of Rs.85/- only. No validity period. Rs.200/- talk value of Rs.180/- only. No validity period. Rs.300/- talk value of Rs.300/- only. No validity period. Rs.500/- talk value of Rs.525/- only. No validity period.
6	<b>Call Charges (Local+STD)</b>	BSNL Network:Rs.1.00 per MCU. Other Network:Rs.1.20 per MCU. ISD call charges as per landline plan of pulse duration 60 secs.
7	<b>SMS Charges</b>	Re.0.40/- per SMS (Local + STD) Rs.5.00/- per international SMS.

**Note:-**

- A. Disconnection of O/G facility immediately after expiry of validity period or talk value whichever is earlier.**
- B. Grace period-A:** 15 days incoming allowed after expiry of validity period.
- C. Grace period-B:** 90 days for permanent disconnection after expiry of validity period.
- D. Time bound to carry forward of balance:** 15 days after expiry of validity period.
- E. Restoration recharge waiver time:** Beyond 7 days after validity expires Rs.50/- may be deducted from balance after recharge.
- F. Initial validity to allow time for first plan recharge:** 15 days time allowed with incoming facility before first plan recharge.
- G. Validity extension on plan recharge from recharge date or last validity date of current plan:**
- If customer, recharge using same plan, validity may start from the next date of expiry of the last recharge.
  - If customer changes plan, validity may start from date of current recharge.

2. **The tariff order will be effective with immediate effect on PAN India basis.**

3. **The Circle should ensure to comply with all regulatory requirements.**
