

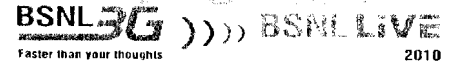

Sub. Tariff for Common Service Centre (CSC) Plans under Wireless Broadband Services (WiMAX) -reg.

In continuation of this office order of even No. dated 20.10.2010 and subsequent orders issued from time to time regarding tariff for Common Service Centre (CSC) Plans under Wireless Broadband service (WiMAX), it has been decided by the competent authority to clarify the WiMAX postpaid tariff plans applicable to CSC as under:-

- i) WiMAX **Installation charge** for CSC will be taken as **NIL**.
- ii) The **Minimum Hire Period** for all WiMAX plans for CSC is **three months**.
- iii) Uniform **FMC for CPE** at the rate of **Rs.50 for Indoor/Outdoor CPE and Rs.40 for USB Dongle** will be charged for Limited as well as Unlimited data plan.
- iv) All other terms and conditions with respect to WiMAX tariff for CSC will remain same.

2. The above WiMAX tariff will be applicable **with immediate effect**.

3. This may be brought to the notice of all concerned for taking necessary action in this regard. Proper advertisement as deemed fit may be made to generate adequate response.


