Sub: Launch of Per Sec. Plan and Per Min. Plan under CDMA prepaid services -reg.

Kindly refer to this office order of even No. dated 15.06.2010 and orders issued from time to time on the subject mentioned above. Now, It has been decided by competent authority to withdraw the existing "1p/sec" and "49p/Min" plans under RUIIM based lifetime services and introduce two new plans "Per Sec. Plan" and "Per Min. Plan" with the following terms and conditions:-

a) RUIIM Based tariff plans:-

c) All other terms and conditions will remain same.

2. The above tariff will be implemented with effect from **28.09.2011**.
