## Circular T&C-CM No. 22/11-12


### Sub: Clarification on tariff for RUIM based IFWT-reg.

Kindly refer to this office order of even No. dated 19.11.2009, letter No. 3-23/2007-R&C dated 24.08.2009, No.24-8/2009-R&C dated 30.12.2010 and subsequent orders issued from time to time vide which tariff for RUIM charges, IFWT charges and promotional offers under CDMA services have been issued. Based on queries received from field units, the following clarifications are issued:-

Query	Clarification
What will be the RUIM charges, in case, IFWT is provided along with RUIM to the customer.	The customer will be charged only for the sale price of IFWT. No separate charge will be levied for RUIM when IFWT is provided by BSNL along with RUIM.
Whether the existing plan 900 and Lifetime are applicable to RUIM based IFWTs.	Yes, all tariff plans are applicable to RUIM based IFWTs.
Whether the promotional offers under prepaid CDMA services re-launched vide Letter No. 24-08/2009-R&C dated 01/04/2011) are applicable on RUIM based IFWTs.	Yes, all promotional offers are equally applicable to RUIM based IFWTs.

2. This may be brought to the notice of all concerned for taking necessary action in this regard.
