Sub: Revision in feature of RUIM based prepaid plan “Pyari Jodi” under CDMA services-reg.

Kindly refer to this office order of even No. dated 31.05.2012 vide which a special RUIM based plan “Pyari Jodi” was introduced for existing BSNL Landline/WLL customers under CDMA services. Now, based on feedback received from field units, it has been decided by the Competent Authority to revise the feature of the “Pyari Jodi” plan as under:-

- a) The customer may choose only one BSNL Landline/WLL number either in his name or in the name of any of his relatives/friends.
 - b) Existing CDMA customers may also be allowed to avail the facility of “Pyari Jodi” plan on request basis.
2. The above revision in feature of “Pyari Jodi” plan will be implemented with effect from **27.08.2012**.
 3. This may be brought to the notice of all concerned for taking necessary action in this regard. Press note and proper advertisement as deemed fit may be made to generate adequate response. In addition to above, all landline/WLL customers may be informed about the scheme through IVRS and printed message in the Landline/WLL bill to make the scheme a success.
 4. This circular is issued based on the approval of the Competent Authority in NWP-CDMA cell File No.69-03/2009-CDMA/Tariff/Vol III/Pt.III.
