Circular R&C No. 128/09-10

Sub: Rationalization of CDMA postpaid tariff-req.

Billing of CDMA postpaid plans have been migrated from SSA based billing to zonal B&CCS in some circles. In view of the above, it has been decided by the competent authority to allow all GSM based post paid tariff plans to CDMA based postpaid services with the following terms and conditions:-


- i) **CDMA full mobility services:-** The postpaid tariff for full mobility CDMA service offered vide this office order No.3-23/2007-R&C dated 07.07.2008 and any subsequent modification/clarification issued from time to time will be withdrawn and the GSM tariff applicable to 2G postpaid mobile services will be made applicable in circles where CDMA billing has been migrated to B&CCS
- ii) **CDMA Fixed/Limited Mobility services:-** GSM tariff plans applicable to 2G postpaid mobile services will be offered as "Alternate Plans" in addition to existing tariff plans for CDMA fixed/limited mobility service in circles where CDMA billing has been migrated to B&CCS. The existing customers in these circles will have the option to switch over to any of the postpaid GSM plans. However, the new customers in these circles will be offered only GSM postpaid plans.
- iii) The circles where CDMA billing is with SSA, the GSM based tariff plans may not be technically feasible. Hence, the existing MCU based CDMA tariff plans will continue till the time the CDMA billing is migrated to GSM B&CCS.
- iv) The GSM based tariff applicable to CDMA based service are subject to technical feasibility. In case of CDMA fixed and limited mobile customers, roaming facility shall not be allowed.
- v) Local call in case of CDMA means Intra Circle calls.
- vi) All the CDMA customers will be provided 1X data service which shall be charged @ 5paise/100KB or unlimited 1X data usage for additional Rs.250/Month, if opted.
- vii) The CDMA activation charges of Rs.100 in case of RUIM and Rs.900 in case of IFWT, (if provided by BSNL) will apply.
- viii) All subsequent revisions/rationalization/clarification issued from time to time in respect of GSM based postpaid plans will also be applicable to the CDMA based postpaid plans.

2. The above tariff will be effective from **15.02.2010**. The implementation of the revised tariff is to be made in accordance with 43<sup>rd</sup> Amendment of Telecom Tariff Orders issued by TRAI.

3. This may be brought to the notice of all concerned for taking necessary action in this regard.

*Respected Sir,*

As you know, BSNL is now offering tariff packages for 'Full Mobility' WLL lines.

For Postpaid mobile connections in case of both GSM and WLL, All-India Roaming is allowed. The names of the Plan packages are also almost the same. But Sir, on comparing the package structure, I am finding that call tariff, especially for STD calls, is very much adversely designed for WLL full mobility lines. For your ready reference, the STD call tariff comparison is presented below :

PLAN	Plan 99	Plan 299	Plan 225	Plan 325	Plan 525
GSM Mobile	49 p / min	–	1 p / sec	12 p / 15 sec	10 p / 15 sec
WLL Mobile	Rs. 1.20 / min	Re. 1/- per min	–	Re. 1/- per min	Re. 1/- per min

In addition, for GSM lines there are other freebies in terms of free calls, free SMS, free GPRS data downloads etc. Thus clearly, packages for the WLL postpaid full mobility lines are customer unfriendly & so, they are unpopular.

Compared to fixed WLL lines, the penalty for full mobility WLL line is extremely severe, viz. from a WLL fixed line all STD calls to other fixed lines are @ Rs. 1.20 per 3 min. only.

So, Sir, kindly look into the matter & get the anomalies removed. For the same level of service the tariff package should also be the same irrespective of technology.
