## Circular T&C-CM No. 95 /12-13

### Sub: Introduction of Special Tariff Vouchers (STVs) under CDMA service –reg.

It has been decided by the competent authority to introduce the following STVs under prepaid CDMA services with the following terms and conditions:-

i) Special Tariff Vouchers:-

ii) The above STVs are subject to the condition that up to one hundred SMS per SIM per day, the SMS charges will be as per the STV subscribed by the customer; and beyond 100 SMS per SIM per day, the SMS charges will be as per the base plan or 50 p per SMS which ever is more.


iii) All other charges as per base plan.

iv) Circle can suitably adjust the MRP of Special Tariff Vouchers (STVs) in the price band upto Rs.5 (+/-) of above price considering the local market conditions, TRAI guidelines and technical feasibility.

2. The above tariff will be implemented with effect from **20.12.2012**. Implementation of the above STVs is subject to technical feasibility.

3. This may be brought to the notice of all concerned for taking necessary action in this regard. Press note and proper advertisement as deemed fit may be made to generate adequate response. Circles may also send SMS conveying the above scheme to the customers.


