Sub: Introduction of RUIIM based Prepaid General tariff plan under CDMA services -req.

Kindly refer to this office order of even No. dated 19.11.2009 and subsequent orders issued from time to time vide which RUIIM based Life time tariff plans were issued. Now it has been decided by competent authority to introduce RUIIM based prepaid General tariff plan under CDMA services with the following terms and conditions:-

a) RUIIM based Prepaid General tariff plan:-

b) RUIIM would be 1X and EVDO enabled and can be used all over India (except Mumbai and Delhi).

c) Normal CDMA prepaid recharge and top-up vouchers will be applicable.

2. The above tariff will be applicable with effect from **01.12.2010**.
