Unlimited voice calls implies unlimited on-net/off-net voice calls in HPLMN and National roaming including in Delhi and Mumbai issued vide No. 26-07/2018-T&C-CM Circular T&C-CM No. 47/18-19 Date: 16.01.2019
2.	Whether the existing data for Plan525 can be revised from 1500MB to 40GB (40Kbps beyond 40GB) and for Plan725 from 30GB to 50GB(40Kbps beyond 50GB) w.e.f 01/02/2019.	Yes ,for Plan 525 unlimited free Data with speed reduced to 40 Kbps after 40GB, For Plan 725, unlimited free Data with speed reduced to 40 Kbps after 50GB.
3.	Status of existing voice freebies /free talk value of plan 525/725?	The existing free talk value / voice freebies will be withdrawn with implementation of unlimited voice facility.
4.	Applicability of this rationalization of plan725/525 vide No. 26-07/2018-T&C-CM Circular T&C-CM No. 47/18-19 Date: 16.01.2019.	Applicable to existing customers and new customers w.e.f. 01.02.2019.
