**Subject: Promotional scheme to offer 5GB complementary data on monthly basis to the post paid Mobile customers under WiFi Hot Spot Services being provided through CAPEX based BSNL WiFi Hotspot & Mobile offload project (4G Plus) being set up by L&T and HFCL on Pan India basis -reg.**
