

b)	Free Talk value	Rs.20	Rs.40
c)	Free Local SMS (in Nos.)	1500	3000
d)	Free Data Usage in MB	500 MB	1000 MB
e)	Validity	180 days	365 days

\*Circles can suitably adjust the MRP of RCVs in the price band upto Rs.3 (+/-) of above price considering the technical feasibility.
