**Circular R&C-CFA No. 52/15-16**

**Subject: Maximum Bandwidth under WiFi prepaid plans to retail customers and to the individual users of the Bulk user WiFi plans- reg.**

1. Kindly refer to this office letter No. 1-1/2015-R&C (CFA) [Circular R&C-CFA No. 40/15-16] dated 26-06-2015 regarding introduction of maximum daily data usage and maximum bandwidth under WiFi prepaid plans to retail customers and to the individual users of the Bulk user WiFi plans.
2. Now, it has been decided by the Competent Authority **to withdraw the instructions regarding maximum speed defined under WiFi prepaid plans to retail customers and to the individual users of the Bulk user WiFi plans vide R&C-CFA letter No. 1-1/2015-R&C-CFA [Circular R&C-CFA No. 40/15-16] dated 26-06-2015.**

**However, the maximum data usage (50 MB) per user per day, defined for the individual users of Bulk user WiFi Hot Spot plans vide above referred letter, shall remain unchanged.**

3. The above instructions shall be **applicable with immediate effect in all the Circles.**
4. All other terms and conditions shall remain the same as per earlier circulars.
5. This circular is issued based on the approval of Competent Authority in Broadband cell file No. 64-277/2013/Wi-Max/Tariff/Pt.2.
