
Provisional result of LDCE for promotion to the grade of SDE(Elect.) was declared vide this office letter of even no. dated 29.07.2011 wherein it was stated "...any discrepancy/error in the result may be brought to the notice of Recruitment cell within 15 days from the declaration of result. Discrepancies/errors pointed out after 15 days of declaration of result shall not be entertained under any circumstances". Accordingly, all the representations received, within stipulated time, in response to para 4 of the said letter have been examined and it was found that an inadvertent error has taken place while processing the OMR answer sheets in respect of candidates of Kerala Circle.

2. To remove the inadvertent error, the OMR answer sheets of Kerala Circle were again processed and as a result four(4) candidates of Kerala Circle have been placed in the list of successful candidates. Accordingly, the provisional result declared vide letter dated 29.07.2011 is modified as per details given below:




