2. The Circle IFAs concerned may intimate the station of posting of the executive (s) within 07 (seven) days from the date of issuance of this order. The leave, if any requested by the executive(s), under transfer, should not be granted under any circumstances by the Circle(s) where they are working presently without prior permission of the CO BSNL. The executive can apply for leave to the Competent Authority at the new place of posting, who will sanction the same if it is justified in the normal course.



7. All IFAs may please check up the up-to-date position regarding the vacancies in the grade of AO/Sr AO in their circles after implementation of the above order and intimate the same to Dy. Manager (SEA), CO BSNL, New Delhi.
