**ORDER**

**Subject: Relieving of the executives in the grade of DE(T)/AGM(T), under transfer to/from Hard /Soft tenure circles/stations.**


Ref: This office Letter No. BSNLCO-PETS/18/1/2020-PERS1 dated 16.06.2020

Kindly refer to this office order dated 16.06.2020 wherein it was requested that the employees under transfer may be relieved from their present unit/circle keeping in view the local COVID-19 guidelines w.r.t. movements. In this regard, it has been observed that the circles are not relieving the officers/executives who are under transfer to other circles, including cases of those officers who have completed their hard/soft tenure.

Further, as per the SR Cell, BSNLCO Letter No. BSNL/5-2/SR/2019 dated 25.06.2020, the last date of implementation of (Hard/Soft) tenure transfers is 22.07.2020. Accordingly, it has been decided that the transfer orders as in Annexure-I may be implemented before 15.07.2020 by the circles concerned, keeping in view the local COVID-19 guidelines w.r.t. movements.

It may kindly be ensured that the guidelines/restrictions issued by the SR cell of BSNLCO in connection with the ongoing Membership verification regarding issuance of transfer orders and implementation thereof, are not violated by any of the above actions. Inconsistencies noticed, if any, in this regard shall be immediately brought to the notice of this office, before implementing.
