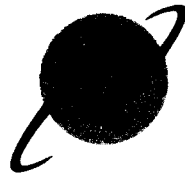

Dear Sir,

As on date, BSNL is flooded with court cases filed in different courts all over the country on a wide range of issues concerning service matters, contracts, regulation, agreement etc. Though every circle is having officers dealing with legal cases in consultation with panel advocates but defence mechanism is found to be un-satisfactory and not up to the mark resulting considerable delays/loosing cases. At times, sudden receipt of court's contempt notices puts the Top-level Management in awkward position. The Management has taken a serious view of such developments.

The Management Committee has discussed the issue in a recent MC meeting and desired to have a system wherein in-house legal human resources i.e. officers with Law Degree could be gainfully utilised to strengthen the Legal stream and develop an ERP-Based monitoring system to handle the legal matters in a concerted and uniform manner. It is, therefore, proposed to develop a full-fledged legal chain, duly strengthened with available expertise (very similar to the vigilance cells working in BSNL at 3 levels – Corporate HQ, Circle HQ & Business Area(HQs) and establishing an ERP-System based monitoring mechanism towards an effective, handling of legal matters in the organisation.

At each level, the concerned set up would ensure uniform process and effective grounds to defend the cases. In case of any referral or assistance, senior hierarchy should be addressed / approached.

On detailed analysis of ERP data on educational qualification, it is found that 212 executives possess degree in Law, as on date. It is felt that optimal utilisation of these qualified personnel in Law would result in an effective, uniform & systematic handling of the court cases with better interpretation / interaction with panel advocates and would be in a better position to draft and review legal matters, contracts, agreements etc. thereby resulting into a merit-based approach to legal cases. Further it would also reduce the overall spending on legal expenses and improve the quality of work.

Thus, it has been decided to utilise the services of these officers gainfully in strengthening the Legal stream and its monitoring system. All the heads of 29 recruiting circles (including NTR) are requested to post required number of such qualified executives at the Circle & Business Area Legal Cells.

A Circle wise list of candidates having degree in Law is enclosed herewith. The list is indicative only as many officers with law degree might not have reported for up-dation of their additional qualifications in ERP. Heads of Circle shall ensure their deployment in Legal Cell optimally. Deficient Circles may report requirement in this regard to the PGM (Pers), BSNL Corporate Office and this will be taken care by deputing the staff from the adjoining circles/Business Area.

Accordingly, due action may be initiated on priority, on the following steps as are devised to meet the above objectives:

- (i) Developing an ERP-based Monitoring System (e-Court Cases) for an effective monitoring of all legal cases at all the 3 tiers at any point of time (i.e. Corporate/Circle/Business Area levels). This job has already been entrusted to PGM (Estt.)/CS&CGM (Legal), BSNL C.O.
- (ii) To ensure a free flow of the referral systems (from Business Area to Circle and then to corporate level legal set ups) and establish uniformity in approach alongwith citing favourable court verdicts on similar cases.
- (iii) Deploying/Posting the executives with legal qualifications to the Corporate / Circle/Business Area legal set up, in optimum numbers (preferably, 1 at BA level, starting with bigger BAs and BAs having larger pendency of court cases, 2 at Circle level and 3 to 4 at Corporate Level).

The Management Committee of BSNL has set a target date of 31.03.2017 to comply with the above. A compliance report in the prescribed format may be furnished to this office at the earliest.


