As per the recommendation of the Committee constituted to go into the details of various instructions issued from time to time and suggest a comprehensive policy for review of result of failed SC/ST candidates and the changes to be made in the scheme and syllabus of the examination in order to bring uniformity, the following modifications have been made in the Scheme & Syllabus of LICE for promotion to the grade of Private Secretary of BSNL field units:

(i) Note 4 of the scheme & syllabus of LICE for promotion to the grade of Private Secretary against 33% quota in the field units of BSNL issued vide this office letter No.25-01/2010-Pers-II dated 22<sup>nd</sup> February, 2011 is revised as under:

(ii) Note 6 below Note 5 is added as under:-

"Negative marking may be adopted in all objective type question papers of LICE and for each wrong answer 25% of the mark of that question should be deducted".
