12. In case of recruitment by promotion/deputation/transfer grades from which promotion/deputation/transfer to be made.	Promotion:- 75% by Junior Telecom Officers (TF) with three years regular service in the grade. 25% by Limited Departmental Examination from amongst Junior Telecom Officers (TF) who have rendered not less than three (3) years regular service in the grade on 1 st July of the year of Examination.	Promotion:- 67% by Junior Telecom Officers (TF) with three years regular service in the grade- 33% by Limited Departmental Examination from amongst Junior Telecom Officers (TF) and the Chemist cadre who have rendered not less than three (3) years regular service in their respective grade on 1 st July of the year to which the vacancies pertain.

3. The relevant RRs of SDE (TF) stands modified to the extent as above. The other contents of the said RRs remains unchanged.
