- 2. Approval of the Competent Authority is hereby conveyed for carrying out necessary amendments in the existing Recruitment Rules of the erstwhile cadres by replacing the existing names of the cadres with the new functional designations as indicated above, at the relevant places appearing in the Recruitment Rules, All other terms and conditions as stipulated in BSNL CO letter No. 2-4/2007-Restg. Vol-III dated 08.06.2018& 6.9.2018 shall remain unchanged.
- 3. All the Circle/SSA/Administrative Heads are hereby requested to carry out the following exercise:-
- (i) To carry out necessary amendments in the existing Recruitment Rules of erst-while cadres viz. TOAs of the four streams, Chargeman of Telecom Factory and Draftsman of Civil/Electrical/Telecom Factory by substituting the existing designations with the new functional designations at the relevant places appearing in the Recruitment Rules.
- (ii) To make necessary entries/changes in the Service Book/ERP Module of the concerned officials with regard to their revised designations.
- (iii) Date of effect of these orders shall be w.e.f. 08.06.2018 in respect of designations mentioned at Serial No. 1 & 2 and 6.9.2018 in respect of designations mentioned at Serial No.3.
- (iv) In respect of erstwhile TOA cadre, the same shall be applicable to all the four streams of TOA cadre viz. TOA(P), TOA(T), TOA(G) and TOA(TG).
